CONDITIONS OF USE

The Applicant Agrees:

(1) To use the image(s), audio, or video only for the purpose or project stated above. Later and different use constitutes reuse and is prohibited. Subsequent requests for permission to reuse image(s), audio, or video must be made in writing. A reuse fee may apply.

(2) To give proper credit for the image(s), audio, or video. Unless otherwise stated on the photographic copy, the credit line should read: **James A. Cannavino Library, Archives & Special Collections, Marist College, USA.** When the name of the photographer or collection is supplied, this should also be included in the credit. The placement of credit should be as follows:

A. Printed material - Preferably the credit line should appear on the same page as the printed copy of the image and immediately adjacent to it. The credit may appear elsewhere in the publication if done in such a way that readers can quickly match individual images with their respective credit.

B. Films, filmstrips, video, or electronic media (including Internet productions) - The credit line should appear on the film, filmstrip, video, or electronic media where other sources are listed. If manuals accompany films or filmstrips, the credit should appear where the subject of the illustration is discussed in the text.

C. Public exhibitions - The credit should appear within the exhibit area.

D. Audio broadcasts – The credit should be read at the end of the broadcast or given when other sources are listed.

(3) Not to digitize images at a resolution higher than 72 dots per inch for use on the Internet, or distribute image(s), audio, or video without written authorization from the Marist College Archives & Special Collections.

(4) To assume all responsibility for questions of copyright and invasion of privacy that may arise in the copying and in the use of the image(s), audio, or video and to assume responsibility for obtaining all necessary permissions pertaining to use.

(5) To defend and indemnify and save and hold harmless Marist College, its Archives & Special Collections, its employees or designates, and the donors and former owners of Marist College Archives or Special Collections, from any and all costs, expense, damage and liability arising because of any claim whatsoever which may be presented by anyone for loss or damage or other relief occasioned or caused by the release of image(s), audio, or video to the undersigned applicant and their use in any manner, including inspection, publication, reproduction, duplication or printing by anyone for any purpose whatsoever.

(6) To supply the Marist College Archives & Special Collections with one complimentary copy of any printed, broadcast, or published work in which one or more image(s), audio, or video appear.

(7) Not to permit others to reproduce the image(s), audio, or video; to destroy any digitized copies of image(s) audio, or video following their use.

(8) Not to place the image(s), audio, or video in another institution, repository, or collection--public or private.

(9) To return to the Marist College Archives & Special Collections the supplied copies of any image(s), audio, or video if they are designated by the Archives & Special Collections for return.

(10) That the Marist College Archives & Special Collections in no way surrenders its own right to publish or otherwise use the image(s), audio, or video, or to grant permission for others to do so. That the Marist College Archives & Special Collections reserves the right to make exceptions or additions to the conditions stated herein.
